By entering the Promotion you confirm that you have read, understood and agreed to these terms and conditions (the 'Terms and Conditions') and that you consent to the processing of any personal details you submit by Co-op in accordance with its Privacy Policy: <https://www.coop.co.uk/terms/privacy-notice>

1. Eligibility:

This Promotion is only open to United Kingdom residents (excluding residents of Northern Ireland) who are members and employee members of Co-operative Group Limited (Co-op) aged 18 years or over as of the date of entry, except employees of the Promoter, its agents, their families and anyone professionally connected with this Promotion.

2. How to enter:

2.1. Purchase a Maltesers Bunny 29g or Maltesers Bunny Orange 29g and swipe your Co-op membership card in a Co-operative Group Food store during the Promotion Period. Temporary membership card holders are automatically excluded from this promotion. Any employees of the promoter (or any of its group undertakings and its agencies who are directly connected with the creation and administration of this promotion) are excluded from entering this promotion. We may ask the winner to provide proof of age.

2.2. Purchase necessary. Only one entry per person.

3. Promotional Period:

The Promotional period will run from 00:00:01 on 28.02.2022 to 00:23:59 on 25.03.2022.

4. Prizes:

4.1. There are 5 prizes available to be won, each consisting of a holiday voucher to the value of £1000.

4.2. The Prize is as stated, non-transferable and no cash alternative is available.

4.3. Any other costs incurred in addition to those set out above and that are incidental to the fulfilment of the Prizes are the responsibility of the Winners.

5. Winner announcement/ Prize claim:

5.1. There will be 5 Winners in total. If you are the winner of one of the holiday voucher prizes, this will be sent in the form of an Inspire e-gift card to the same email address used to provide notification of your selection as a prize winner. The e-gift card will be pre-loaded to the value of £1,000 and will be valid for 18 months from the date of issuance. No cash alternative will be offered. Co-op will use the address registered on the winner's Co-op membership account to notify them. The Winner may withdraw from the promotion by responding "opt-out" within 48 hours of receiving the notification email. Co-op will pass the winner's email address to the Promoter so the Promoter can contact the winner via email to organise the prize fulfilment.

5.3. The Winner of the Prize must respond within two (2) business days of being notified by the Promoter. If the Winner does not respond within such timeframe, then the Winner's Prize will be forfeited and the Promoter shall be entitled to select another winner in accordance with the process described above.

5.4. If a Winner rejects their Prize or the entry is in breach of these Terms and Conditions, the Winner's Prize will be forfeited and the Promoter shall be entitled to select another Winner.

6. Privacy and Data Protection:

6.1. Personal data received in the course of the Promotion will be used in accordance with applicable data protection law and in accordance with the Promoter's Privacy Policy: <https://www.mars.com/privacy>. By participating in the Promotion you consent to the Promoter processing your personal data for the purposes of carrying out the promotion and notifying and advertising the winners.

6.2. By entering the Promotion, you consent that, should you be the winner, the Promoter or any of its affiliates can publish your name, town of residence and face and/or likeness in

any sites administered by the Promoter or any of its affiliates. Winner may withdraw consent to such use of personal information by writing to the Promoter or by using the opt-out process outlined in the Promoter's Privacy Policy.

7. General:

7.1. The Promoter reserves the right, in exceptional circumstances, to award an alternative prize of equal or greater value, should the Prize (or any element of it) become unavailable for any reason.

7.2.
