- 1. The Promoter:** Mars Wrigley Confectionery UK Limited, 3D Dundee Road, Slough, Berkshire, SL1 4LG.
- 2. Eligibility:** This promotion is open to UK residents, aged 18 years or over at the date of entry, excluding employees of the Promoter and their immediate families, associated agents or anyone professionally connected with the draw.
- 3. Promotional Period:** The promotion will run from 00:00:01 on 03.03.22 to 23:59:59 on 20.04.22.
- 4. Entry Instructions:** To enter, text SPIDERMAN to 82727. No purchase necessary. Participants submitting a valid text entry will receive a text message thanking them for entering the promotion. Time taken to receive this text message may vary. A text entry will be charged at your standard network rate (and may not be included within any free text packages). Please check with the bill payer before sending a text entry.
- 5. Maximum 1 entry per person.**
