Eligible Entrants: Entry is only open to Australian residents who are 18 years and over who are Petbarn Friends for Life members.

Employees of the Promoter, contractors, agents of supplier(s) and sponsors of the Promotion and their immediate families are ineligible to enter. Immediate families means spouse, de facto spouse, parent, child or sibling (whether natural or by adoption) and grandparents.
