NO PURCHASE NECESSARY TO ENTER OR WIN. VOID WHERE PROHIBITED.

By entering, you agree to these these Official Rules and the decisions of Mars Wrigley Confectionery US, LLC (the "Sponsor"), which shall be final and legally binding in all respects; and you agree to provide your information to the Sponsor which will only be used in accordance with the Sponsor's privacy policy which may be viewed at <https://www.mars.com/privacy>.
